Coins may be delivered in multiple shipments at different times. Orders will be shipped to a single location only. Please allow approximately 2-3 weeks for delivery. The United States Mint reserves the right to accept or reject coin orders in any combination or option(s) it determines to be in its best interest. In the event a particular coin option is sold out, the United States Mint reserves the right to either process partial orders and make refunds or return orders in their entirety.

Notice to customers making payment by check: If you send us a check, it may be converted into an electronic fund transfer (EFT). The debit from your account will usually occur within 24 hours, and will be shown on your regular account statement. We will destroy your original check but keep a copy of it. If the electronic fund transfer cannot be processed for technical reasons, you authorize us to process the copy of your check (see www.usmint.gov for full details).
