The Denver Mint is located at 320 West Colfax Avenue. From I-25 take the Colfax Avenue exit and go east on West Colfax. The mint is 1.5 miles east on the right side between Delaware and Cherokee Streets. The visitor's entrance is on Cherokee Street, on the east side of the building. Allow time to find parking. The Mint does not provide parking. Meters and public parking are available in the area.

**Visitors must be at the tour entrance 30 minutes before tour time.** Late arrivals will not be admitted. Tickets are required for all tours. The United States Mint is a secured facility. All visitors are subject to a security screening, to include metal detection and x-ray examination of hand-carried items. ***The Mint does not provide storage for any items. Tours are for adults and children 7 years and older. Children under 7 (including but not limited to infants and toddlers) will not be permitted on the tour.***

#### **Permitted items:**

- A palm-sized wallet
- Powered-off cameras/cell phones (**photography is prohibited while on Mint premises**)
- Umbrellas, walkers, wheelchairs
- Empty water bottles
- Medical items necessary for the safety and health of the visitor

#### **Prohibited items include, but are not limited to:**

- Handbags, purses, fanny packs, tote bags, backpacks, packages, and other bags
- Food and liquids
- Lighters and matches
- Weapons, including but not limited to pocket knives and personal protective devices such as pepper spray
